Our Small-Cap Strategy seeks long term capital appreciation by investing in equity securities of small capitalization companies in the US that we believe to be mispriced by the market.

1Q19 Highlights

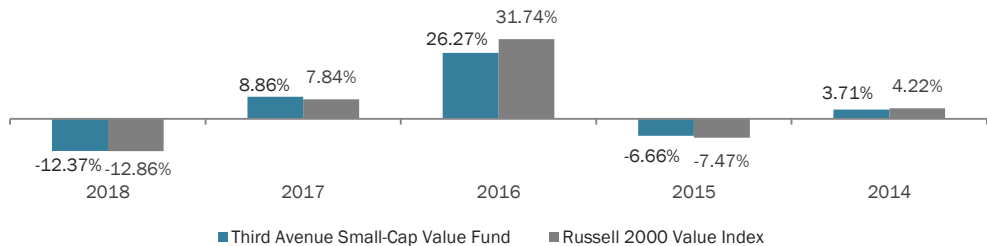
- o Attribution: Contributions across the portfolio were broad given the market rally. Top position, engineering and construction firm, MYR Group led the way rising 23% after another stellar 1Q earnings report. Management continues to execute despite challenging end-markets. The underperformance was caused by ATN International. ATN International is a holding company that reported weak fourth quarter results in its US telecom business. Fund Management remains confident in the well-capitalized, owner-operator and added to the position in 1Q.
- o Activity: Activity was muted as two positions were eliminated (Tetra Tech and Standard Motor Products) as the risk/return profiles of those companies were no longer favorable. International holding company, Argan was added to the portfolio. It is a well-capitalized, owner-operator. 40% of the market cap is cash and the company successfully improved its backlog in 2018. Management's strong execution track record gives us confidence the company is poised for robust compounding over the next few years. The number of positions declined to 32 at quarter-end as a result of the changes.
- o Positioning: At quarter-end, the Fund maintained a 67% allocation to long-term compounders and a 31% allocation to time-arbitrage investments. The cash balance was 2%.

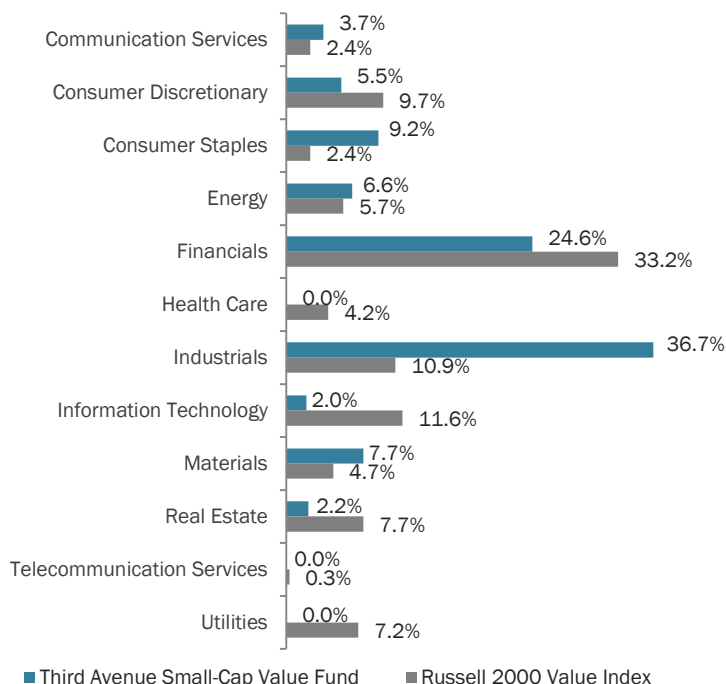
