# 10. COST BASIS TAX REPORTING

Third Avenue Funds is responsible for tracking and reporting to the IRS your realized gains and losses on covered shares. In general, these are shares acquired on or after January 1, 2012.

**Third Avenue Funds's** default tax lot identification method is **Average Cost (AC)**. If you do not wish to use Average Cost, you may change to another method below.

Note: IRS Regulations do not permit the change of the method on a settled trade.
